



GROUP TOUR ENTRY TERMS & CONDITIONS - 2026

Group Entry Discounts

ATR offers discounted entry pricing for eligible group bookings:

- 4–9 entries: Eligible for the advertised Group Entry Discount
- 10 or more entries: Eligible for the advertised Premium Group Entry Discount.

2 Day Option

- 4–9 Cars: \$1,200 per vehicle
- 10+ Cars: \$1,000 per vehicle

3 Day Option

- 4–9 Cars: \$1,500 per vehicle
- 10+ Cars: \$1,200 per vehicle

Discounted rates apply only where the minimum qualifying number of fully paid entries is achieved.

Group Registration Process

- A designated Group Coordinator must be nominated at the time of application.
- ATR will issue a unique group discount code to the group via emails provided by Group Coordinator.
- The discount code may only be used by entrants forming part of the approved group booking.

Payment Requirements

Groups of 4–9 Entries

- All entries must be submitted and paid in full at the time of application to qualify for the group discount.

Groups of 10+ Entries

- All entries must be submitted and paid in full at the time of application to qualify for the group discount.

Entry applications will not be considered confirmed until full payment has been received.

Minimum Entry Numbers

- Group discounts are conditional upon the minimum qualifying number of entries being achieved and maintained.
- If the minimum group size is not reached by the nominated closing date, ATR reserves the right to:
 - Remove the group discount and adjust entries to the standard entry fee; or
 - Invoice the Group Coordinator for the difference between the discounted and standard entry fees.

Withdrawal & Cancellation

- If one or more entrants withdraw from a group booking and the remaining number of entries falls below the qualifying threshold, ATR reserves the right to recalculate all affected entries at the applicable entry rate.
- Any shortfall resulting from withdrawn entries may be invoiced to the Group Coordinator.
- Standard Event refund policies will apply to all individual entrants.

Group Coordinator Liability

The nominated Group Coordinator acknowledges and agrees that:

- They are responsible for coordinating participating entrants within their group.
- They will ensure all entrants are aware of and comply with the Technical & Supplementary Regulations, and these Terms & Conditions.
- Should the qualifying group numbers not be achieved, maintained, or paid in accordance with these Terms & Conditions, ATR may invoice the Group Coordinator for any outstanding balance, discount shortfall, or fee adjustment arising from the group's booking.
- Any such invoice must be paid within the timeframe specified by ATR.

ATR reserves the right to approve, reject, amend, or withdraw any group member, tour group or discount arrangement at its sole discretion and at any time before the commencement, or during the Event.

Submission of a group entry application constitutes acceptance of these Terms & Conditions.
