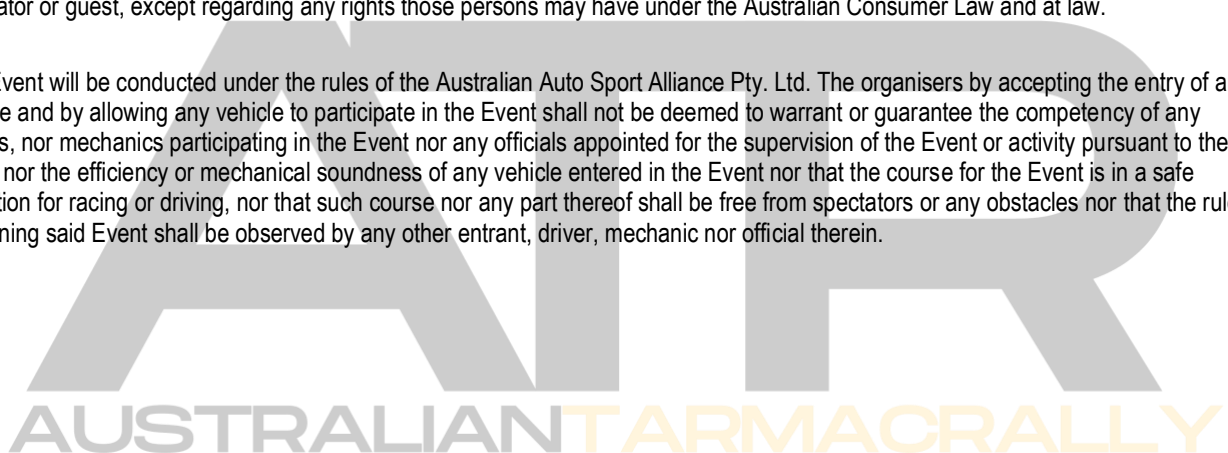
MOTORSPORT IS DANGEROUS.

Motorsport activities are inherently dangerous recreational activities, and there is a significant risk of injury, disability, death or property damage. If you do not wish to be exposed to such risks, then you should not attend or participate in Motorsport activities.

Participants, spectators, officials and guests are warned that motor racing, including tarmac rally, is dangerous, and accidents can happen. All care is taken to protect participants, officials, spectators, guests and the public, but participants, spectators, and guests entering the Event area are warned that there is a possibility of an accident, causing personal injury or death, property damage or economic loss.

By entering or participating in an Event, the participant or guest acknowledges that the Event has a degree of danger and the owners, organisers, promoters, participants or other persons having any connection with the promoting, organising or conduct of the Event shall have no liability, either in tort or contract, for any personal injury or death, whether caused by negligence or otherwise, to the participant, spectator or guest, except regarding any rights those persons may have under the Australian Consumer Law and at law.

The Event will be conducted under the rules of the Australian Auto Sport Alliance Pty. Ltd. The organisers by accepting the entry of any vehicle and by allowing any vehicle to participate in the Event shall not be deemed to warrant or guarantee the competency of any drivers, nor mechanics participating in the Event nor any officials appointed for the supervision of the Event or activity pursuant to these rules, nor the efficiency or mechanical soundness of any vehicle entered in the Event nor that the course for the Event is in a safe condition for racing or driving, nor that such course nor any part thereof shall be free from spectators or any obstacles nor that the rules governing said Event shall be observed by any other entrant, driver, mechanic nor official therein.



1. ENTRY FORM, ENTRIES & ENTRY FEE

- All entries are to be made via the online competitor portal, accessible from <http://www.tarmacrally.com/>
- Entry fees and cut-off dates will be published on <http://www.tarmacrally.com/>
- Acceptance of entry, issued on completion of the entry process, is deemed an invitation to compete. Incomplete or not accepted entries will be contacted by the Organiser for more information and discussion.

2. CREW REQUIREMENTS

2.1. DRIVER AND PASSENGER

- All drivers, passengers and co-drivers must hold a current Civil Licence.
- All drivers, passengers and co-drivers must hold a current AASA General Speed Licence (<https://www.aasa.com.au/general-speed-licence>)
- All cars may have a maximum of two (2) occupants (Driver & Co-Driver or Driver and Navigator).
- Helmets: Drivers, Co-Drivers, and Navigators must wear helmets and apparel that comply with the current Australian Standard and the AASA Regulations. Helmets and Apparel requirements in summary.

A helmet complying with one or more of the following standards must be worn:

- Australian or NZ standard AS/NZS1698
- European ECE 022 with 04 or 05 amendments
- Snell SA2005, Snell SA2010, Snell SA2010H, Snell SA2015
- British Standard BS6658 A/FR
- SFI 31.1

It is recommended that all Drivers, Co-Drivers and Navigators wear an approved (FIA, SFI or similar) FHR frontal head and neck restraint system (HANS device). FHR is recommended but not a mandatory requirement for Tour participants.

Apparel: Apparel complying with the requirements below must be worn:

- Non-flammable* (i.e. natural fibre*) clothing/apparel that covers the person completely from mid-neck to wrist to ankles. Alternatively, single or two-piece driving suits to SFI 3.2A Grade 1 / SFI 3.4, or recognised international equivalent.
- Socks of non-flammable material.
- Fully enclosed footwear with non-synthetic uppers and low heels. Footwear shall not extend above the general ankle area (i.e. no long boots). Boots for drivers should be close-fitting.

3. DRUGS IN SPORT

- Crew members may be required to submit to drug testing to confirm the absence of prohibited substances, in accordance with the AASA Drugs in Sports Policy.
- Compulsory alcohol testing for driver, co-driver and passenger will be carried out each morning prior to the commencement of the event and may be repeated at any time during the event. Drivers, co-drivers and passengers are reminded that there must always be a reading no higher than 0.00 (blood alcohol content %) during the event.

4. ALL VEHICLE REQUIREMENTS

4.1. NUMBERS AND SIGNAGE

- All vehicles must keep the left and right front doors available for door panels and numbers, which will be supplied by the organisers. A space of 200mm x 200mm must also be left for smaller numbers without background panels to be fitted to the side screens of the vehicle. Refer to Event Supplementary Regulations.
- All vehicles must keep a space 200mm high across the top of the windscreen available for the sponsor banner. Refer to Event Supplementary Regulations.
- Signs from sponsors or supporters of individual cars may be displayed on the vehicle, provided they do not interfere with the door or windscreen panels mentioned in 1.1 and 1.2 above and are printed and applied professionally and tastefully and are not in conflict with any sponsors of the Event. The organisers reserve the right to have any advertising they consider distasteful or inappropriate removed from a competing vehicle before it is permitted to start.

- The organisers reserve the right to provide additional Event sponsor decals and require them to be displayed prominently on all vehicles.
- No responsibility for any damage to vehicle paintwork during the removal of Event signage will be accepted by The Organisers. The entrant agrees to and accepts this as a condition of acceptance of entry.

4.2. VEHICLE SAFETY CHECK

- All vehicles must be safety checked prior to starting in the Event. Vehicles must be presented to safety check in a roadworthy condition, fully compliant with all these regulations and all other requirements, during the scrutineering times posted in the Event schedule or posted on the website.
- A vehicle may be inspected, or re-safety checked at any time during the Event to ensure that the vehicle is in an acceptable condition to continue, that all safety equipment is present, serviceable and correctly positioned, and that the eligibility of the vehicle remains unchanged.
- All vehicles must pass a safety check to be allowed to complete/continue to compete in the Event. If, during the Event, the Chief Scrutineer considers a vehicle to be non-compliant, he/she may direct it to be repaired before recommending that the Clerk of Course or an authorised official approve its continuation in the Event.

5. ALL VEHICLES TECHNICAL AND COMPULSORY

5.1. TECHNICAL REQUIREMENTS FOR ALL VEHICLES

The spirit of the Regulations is to ensure that all vehicles compete in a safe environment and are mechanically sound. These Regulations are to be used in conjunction with AASA Standing Regulations for Tarmac Rallies, the AASA National Competition Rules (NCR's) and any specified Event documentation, such as Supplementary Regulations and any further bulletins.

5.2. VEHICLE ELIGIBILITY

- Each vehicle must have at least two seats.
- Each vehicle must have been capable of achieving road registration when first released. THESE REGULATIONS DO NOT REMOVE THE REQUIREMENT TO COMPLY WITH ANY CIVIL OBLIGATIONS OR REGULATIONS, AND COMPLIANCE WITH ALL SUCH PROVISIONS IS THE RESPONSIBILITY OF THE COMPETITOR.

5.3. ROADWORTHINESS AND ROAD REGISTRATION

- All vehicles must be the subject of a valid road registration or have a suitable permit (i.e. Temporary or Rally permit) from a competent civil authority for use on public roads. All vehicles must have a current third-party insurance policy, including, where necessary, an extension for competition use relevant to state or territory requirements from the state of issue.
- All statutory requirements relating to the use of such permits/registration must be met. Unregistered vehicles that are to compete in the Event may obtain a special motorsport unregistered vehicle permit by applying to Vic Roads and must be applied for a minimum 14 days before the event. Please email info@tarmacrally.com to receive the form.
- Left-hand drive vehicles are permitted.

5.4. AUTHORITY TO ENTER VEHICLE

The vehicle must be entered by the bona fide owner of the vehicle, or a person having the written authority of the bona-fide owner.

5.5. OIL LEAKS / DAMAGED ENGINE

- If any official requests repairs to a vehicle to prevent or eliminate oil leaks or spillage, such repairs must be carried out to the satisfaction of the Chief Scrutineer. If a vehicle continues to leak or spill oil the vehicle may be refused permission to continue in the Event. Any Stage official is empowered to prevent, under the above circumstances, a vehicle from starting a stage.

- On engines with a closed or recirculating crankcase ventilation system, a catch can is not required to be fitted. This system will be fitted as factory standard on any road car. In the absence of the above, an engine fitted with any crankcase breather/s discharging to atmosphere must have fitted to each breather a “catch can” or container (which must be visually empty at the start of each stage) The capacity of the catch can shall be a minimum of two litres. If a competitor damages an engine while driving (including in a transit stage) which results in an oil leak, they must immediately pull off the driving line and stop as soon as safe to do so.

5.6. HEADLAMPS & LIGHTING

- Vehicles must have lighting and signalling equipment that complies with civil regulations applicable to the State or Territory where the Event takes place.

5.7. WHEELS & TYRES

- Wheels and tyres shall be roadworthy. Tyres must be marked legal for road use.
- Each tyre valve shall be fitted with a valve cap.
- A maximum of one metallic spacer may be used behind each wheel.

5.8. TYRE AGE LIMITATION

- All tyres fitted to vehicles participating in the Tour category must not exceed three (3) years from their date of manufacture.
- The tyre manufacture date shall be determined by the DOT (Department of Transportation) code moulded into the tyre sidewall, which indicates the week and year of manufacture.

Safety Rationale: After three years from the date of manufacture, tyre rubber compounds undergo natural degradation through oxidation and environmental exposure, resulting in:

- Hardening of the rubber compound significantly reduces grip levels
- Diminished wet-weather performance, particularly critical for Australian conditions
- Increased risk of tread separation and structural failure
- Compromised braking distances in both dry and wet conditions

Competitors must present tyres for inspection at scrutineering, where officials will verify compliance with the three-year age limitation. Any vehicle found with tyres exceeding the three-year age limit will not be permitted to start until compliant tyres are fitted. Random tyre age checks may be conducted throughout the event at the discretion of the Chief Scrutineer

6. FUEL

Any commercially available fuel legal for use “on road” including ethanol blended is permitted to be used during the Event.

7. EXTENSIBLE STRAPS

Extensible straps (e.g. ‘Octopus’ straps) shall not be used to hold down objects of more than 100g mass inside the vehicle.

8. CAMERAS

- Cameras and video recorders may be fitted to vehicles.
- The mounting of any on-board camera shall be to AASA Regulations and approved by the Chief Scrutineer.
- No camera may be fitted in such a way that it relies solely on a suction cup mounting.
- Cameras are not to be mounted on Helmets

9. SRS AIR BAGS

Vehicles fitted with SRS (Supplementary Restraint Systems – airbags) must NOT have any equipment mounted in front of the airbag.

10. ECS & ANTI-LOCK BRAKES

Vehicles fitted with ESC or ABS (anti-lock brake systems) should not have these systems disconnected or deactivated.

Any road vehicle in sound and roadworthy condition should meet the above requirements.

11. ALL VEHICLES – COMPULSORY EQUIPMENT

11.1. FIRE EXTINGUISHERS

Each vehicle is to carry a hand-held extinguisher; the fire extinguisher shall meet the following criteria:

- Brackets for all demountable FSS must be from steel of minimum thickness 3mm, or aluminium alloy of 4mm thickness, at least 30mm in width. The bracket must be bolted to the body shell by at least two 6mm bolts with load-distributing washers, or by two screwed or bolted clamps of 15mm² cross cross-section to the safety cage.

11.2. FIRST AID KITS

Each vehicle is to carry on board a first aid kit that can be easily accessed.

11.3. OK/SOS SIGNS

Each vehicle is required to carry an OK/SOS sign min. A4 size at all times

OK/SOS signs are included in the safety handbook and are available at no charge from the organisers at the time of documentation.

11.4. SEATBELTS/HARNESSES

All vehicles must be fitted with approved lap sash seat belts for each crew member as a minimum requirement.

Safety harnesses that comply with the requirements listed below are not mandatory but recommended.

Safety harnesses shall be marked as having compliance to one or more of the following standards:

- ECE 16 (European Standard)
- SFI 16.1 (SFI Standard)
- AS 2586 (Australian Standard)
- 8853/98 or 8853-2016

Safety harnesses shall be mounted as per AASA requirements. Please refer to: <https://aasa.com.au/regulations/appendices/Appendix 5-Occupant Restraint Systems>

Any seat belt or harness showing visible signs of wear, damage or degradation will be rejected. Seat belts or harnesses must always be worn when the vehicle is moving.

11.5. SEATS

Vehicles must be equipped with a minimum 2 seats (one for each occupant).

The material from which seats are manufactured is free, including carbon fibre and Kevlar, provided each seat is compliant with one or more of the following:

- The original seat as supplied by the OEM for the vehicle, or

- A seat licensed by the SFI Foundation to the SFI 39.2 standard, or
- A seat in compliance with the requirements of an internationally recognised motorsport sanctioning body, or
- A seat that has no provision for backrest adjustment, incorporates a head restraint and is supplied by a manufacturer recognised by the AASA.

Seats shall be mounted in accordance with the factory/OEM or seat manufacturer's instructions. For further information on seat requirements and the mounting of an aftermarket seat, please refer to the AASA Standing Regulations for Tarmac Rally.

11.6. WINDSCREEN & GLASS

Vehicles must be fitted with a laminated glass windscreen or a factory/OEM only non-glass windscreen. The use of silvered or tinted films is authorised on the side and rear windows only. Any film must comply with the vehicle regulations in the relevant state.

11.7. SAFETY CAGE – NON-MANDATORY

Safety Cages in compliance with AASA Safety Cage regulations are permitted.

11.8. BONNET RESTRAINTS

Each vehicle must have at least two independent fastening systems, of adequate strength and limited extensibility, which simultaneously hold the bonnet closed. Factory/OEM bonnet catches with safety catch meet this requirement.

11.9. TOW POINT

To facilitate the ease of recovery of a vehicle, it is recommended that all cars be fitted with an easily identifiable tow point. Removable factory towing eyes shall be installed prior to the start of the Event.

12. TOUR BOSS

The Tourboss navigation and safety system is **mandatory** for all participating vehicles in the Lifestyle Rally. Tourboss is supplied as a smartphone application by the event organisers and provides official route navigation, live tracking, and emergency communication functions.

Participants must download and install the Tourboss app prior to the event, and event organisers will provide an event invite code or will pre-register participants.

Tourboss requires Location Services set to “Always”, and notifications must be enabled. These permissions allow continuous GPS navigation and receipt of real-time event updates, including when the app is running in the background.

The Tourboss app must remain open and running during all stages. Tourboss includes an SOS emergency alert system. Pressing the SOS button initiates a 10-second countdown; if not cancelled before expiry, an alert is automatically sent to event officials for immediate response.

Failure to comply with the above will result in immediate exclusion from the full event.

13. COMPULSORY REQUIREMENTS INTERPRETATION

Officials and Scrutineers shall be considered Judges of Fact in relation to all compulsory requirements. Whilst every attempt has been made to ensure these regulations reflect the provisions that will be in place at the time of the Event, the timing of the Event and publication of the Supplementary Regulations can make that difficult.

Any changes made by AASA to the relevant provisions of the AASA Regulations shall supersede these requirements and in addition, the organisers reserve the right to amend the safety equipment to reflect such requirements.

14. GENERAL

The organisers reserve the right not to accept any crew, vehicle, or crew/vehicle combination. Acceptance of a vehicle or crew in one year does not necessarily mean that the vehicle will be accepted in the following year/s.
